Academic & Behavior Expectations

- _____ • I understand that my child must maintain a 2.0 or higher quarterly GPA (2nd – 5th).
- _____ • I understand that my child must adhere to the OCPS Student Code of Conduct and discipline policies.
Discipline offences violating the OCPS Student Code of Conduct at a Level 3 or Level 4 warrant review for probation and/or removal.
- _____ • I understand that students who fail to meet academic and/or behavior standards will be placed on an appropriate probation for **one grading period**. If the violation is corrected during the specified time period, the probation will no longer apply. If there is insufficient improvement at the conclusion of the probationary period, the student will be exited from the magnet school or magnet program and will be required to return to the zoned school at the end of the first semester, or the end of the school year, whichever occurs first.
- _____ • I understand that my child is expected to attend school daily and maintain positive school attendance. Written excuses must accompany any absence. Students who have accumulated 10 unexcused absences in a 90 day period will be placed on probation. Please note that 5 unexcused tardies equals 1 unexcused absence.
- _____ • I understand my child will participate in required exhibits, performances, competitions, and/or auditions which may necessitate other commitments outside of the typical school day.
- _____ • I understand, that as a parent, I must be supportive of my child and his/her schooling. As such, I am expected to review classwork and homework, as well as, attend parent conferences, performances, and other activities sponsored by the school as part of my intent to contribute to my student's success.
- _____ • I understand that as part of the magnet program at Maxey Elementary, school uniforms are required.
